

Competition Terms & Conditions

VIP ticket giveaway – Giants Live: Europe’s Strongest Man 2026

1. Promoter

2. Eligibility

- 2.2 Employees of Castle Water, their immediate families, or anyone professionally connected with the competition are not eligible to enter.

3. How to Enter
